## Minutes

1. Call to Order/Roll Call – Chair Steve Stevenson
  - Meeting was called to order at 3:05 p.m.
2. Public Comments
  - M. Burns reported that the Stockton Collegiate School was moving forward and that they would also be taking over the old In-Shape Gym location and it would be used for special school events and serve as a school gym.

- Sophoan Sorn from the San Joaquin Film Society reported that for 2009 the Film Society had presented over 200 new feature and short films from over 40 nations and over 100 other events.
- Barbara Zaruba stated that she was disappointed that the Art walk for 2010 would be cut from six months to three. She stated she had seen a huge growth in the Art walk at the Law Library. E. In order to use the T3 the change would have to come from the State level. S. Stevenson stated that the Alliance should be included in any and all meetings concerning the T3. The board will be updated as new information on the progress of getting the T3 legalized comes forward.
