- 1. Call to Order/Roll Call
 - Meeting was called to order at 3:45pm
- 2. Public Comments
 - K. McNickle introduced Dan Dixon as a new candidate for the board of directors. Mr. Dixon gave a brief history of his business and his properties in the downtown area. M. Cort stated that she was very excited about him coming on board as a new member.
- 3. Executive Director's Report
 - Huber reported on how well the safety ambassador program was progressing. He showed a couple of
 videos from some of the night patrols. He also reported on the state-owned property that is behind in
 its assessments. He stated that Visionary Home Builders and the states general services were
 together to get it settled.

 - M. Huber reported that the money that was not spent on the lighting program because of the time limit expiring, went back into the general fund. J. Rusten explained about the placemaking program and how it would work. Discussion on who can apply, how to apply and how it can help businesses downtown. Committee projects can also go through this program for funding. M.Cort expressed her frustration and disappointment about the funds reverting into the general fund and how this new program will work. G. Trinchera explains that at the end of the year the budget needs to be at zero. All projects must be on a timely basis, sub committees must generate action plan and execute the project in a timely manner.
