- 6. L. Held Resignation Information Item
 - K. McNickle shared that L. Held resigned from the Board in December.
 - Discussion occurred regarding the process for Board nominations. C. Wood shared that the DSA CEO is responsible for appointing Board members, so if anyone has a potential Board member to suggest, they should send the recommendation over to C. Wood or M. Huber.
- 7. Loan Performance Updates/Loan Delinquencies/New Applications Informational Item
 - C. Wood shared that The Campus continues to make payments on their DSELF loan, and the Deliberation has continued to defer their payments.
- 8. Revised DSELF Program Promotion Discussion Item
 - For promotion, the Board inquired as to whether there were updated DSELF marketing materials, and C. Wood shared that they were updated and had been promoted via the DSA's business newsletter and on social media. C. Wood also noted that she could share the links to the updated documents with the Board.
 - N. General Meeting Requirements:

Public Comments: The law provides the opportunity for the public to be heard on any item within the subject matter jurisdiction of the Board, before or during the consideration of that item by the Board. For all items, including items *not* on the agenda, the public comment time at the start of each meeting is appropriate. The person addressing the Board is limited to five (5) minutes unless the Chairman of the Board grants a longer



period of time as appropriate to manage the Agenda. State law does not allow action to be taken on any item not on the Agenda. The Conference Room is handicapped accessible.

This agenda shall be made available upon request in alternative formats to persons with a disability, as required by the Americans with Disabilities Act of 1990 (42 U.S.C. § 12132) and the Ralph M. Brown Act (California Government Code § 54954.2). Persons requesting a disability related modification or accommodation in order to participate in the meeting should contact the Executive Director of the Downtown Stockton Alliance at 209-464-5246, during regular business hours, at least twenty-four hours prior to the time of the meeting.
